We further swear that we will not violate any of the ordinances of the Village of Broadview or the laws of the State of Illinois or the laws of the United States of America, in the conduct of the place of business described herein and that we have read and understand Title 3, Chapter 3 of the Village of Broadview Municipal Code.

We agree to report and complete written documentation to specify any changes to the content of this renewal, whether they occur before or after a license is issued, to the Village of Broadview within fourteen (14) days after the change. We agree to notify the Village of Broadview of any and all changes in ownership, corporate stockholder shares, corporate officers, and directors or any changes to the membership interest in a limited liability company or change to the manager as it needs to be reviewed by the Village. We understand and acknowledge that any changes to the managers, owners, or entity structure could result in the suspension of the liquor license if not in compliance with Illinois and local laws. Further, we understand that the license issued is not transferable.
