**NOTICE OF PUBLIC HEARING CONCERNING THE ANNUAL BUDGET OF THE VILLAGE OF

(FISCAL YEAR COMMENCING MAY 1, 2020 AND ENDING APRIL 30, 2021)**

PUBLIC NOTICE IS HEREBY GIVEN that the Corporate Authorities of the Village of Broadview, Cook County, Illinois (the “*Village*”), will hold a public hearing on the 18th day of May, 2020, at 6:30 P.M. The hearing will be held in the Village Hall (Boardroom) of the Village of Broadview, 2350 South 25th Avenue, Broadview, Illinois and broadcast on the Village’s website. The purpose of the hearing will be to consider the tentative Annual Budget for the Village of Broadview for the fiscal year commencing on May 1, 2020 and ending April 30, 2021 and to receive public comments on the same.

In response to the growing concern related to the spread of the novel Coronavirus Disease (COVID-19) and pursuant to executive orders issued by the Governor of Illinois and the Village President in response to COVID-19, public comment requests for the meeting may be written and submitted to the Village Clerk at least one hour and thirty minutes before the scheduled meeting via email to the Village Clerk Kevin McGrier at kmcgrier@broadview-il.gov. Persons submitting public comments via email are strongly encouraged to provide their name, their telephone number, and their home address to allow the Village to contact them if so merited and if such information is relevant to their comment. Persons who desire may make in-person comments during the meeting and will be brought into the meeting room one-person at a time. All social distancing protocols pursuant to the Governor’s Executive Order 2020-32 (COVID-19 Executive Order No. 30) and the Village’s COVID-19 Executive Order No. 2020-03 (extending Executive Orders No. 2020-01 and 2020-02) shall be observed and enforced.
