This Permit, including this waiver, is executed and entered into by and between the individual/entity (the "Permittee") desiring to conduct directional boring/horizontal boring ("Underground Boring") and the Village of Broadview, an Illinois Municipal Corporation (the "Village").

Permittee has been approved to conduct Underground Boring at the following location:

As consideration for being allowed to conduct Underground Boring in the Village, the Permittee, acknowledges, appreciates, understands, and agrees to the following:

- 1. The Village's Director of Public Works approved the Underground Boring for the site listed above pursuant to Title 8, Chapter 9 of the Village Code.
- 2. Permittee agrees to observe all Village and county ordinances and codes and all local, state and federal

statues, rules and regulations now in force or which may hereafter be in force, and the Underground Boring must be in compliance with all directives of the Village's Director of Public Works, as well as all applicable building codes and applicable laws.

- 3. The Permittee desiring to conduct Underground Boring under the rights-of-way shall be required as a condition of their permit to have an inspector, employed by the Village or a qualified third-party inspection service (the "Inspector"), on site during the act of the Underground Boring.
- 4. The cost of this Permit shall be \$100.00 if the plans are reviewed by the Village. If a third-party must review the plans, the permit fee will be \$50 plus the costs for the third-party review.
- 5. The Inspector shall be retained by the Village; however, the costs of said inspection shall be paid by the Permittee desiring to use Underground Boring. The Village will provide an estimate of third-party costs (the "Costs") associated with the inspection, attached hereto as Exhibit A, and the Permittee hereby consents to the Costs. The Permittee is required to deposit with the Village a bond or note to cover the Costs.
- 6. The Permittee shall further provide and attach to this Permit detailed plans and drawings related to the proposed Underground Boring. The Permittee shall also be available to meet and confer with (i) the Public Works Director, or designee; (ii) the Building Commissioner, or designee; and (iii) the Inspector related to this Permit and any plans and drawings submitted.
- 7. To the fullest extent permitted by law, Permittee expressly waives, releases, covenants not to sue and shall indemnify, defend and hold the Village, its past, present and future officials (whether elected or appointed), trustees, employees, volunteers, insurers, directors, agents, officers, representatives, attorneys, independent contractors, successors or predecessors, and any other party in any way related to the Village, harmless from and against any and all claims, losses, demands, liabilities, penalties, liens, encumbrances, obligations, causes of action, costs, expenses (including reasonable attorney's fees and court costs) and damages (whether actual or punitive) of any kind related to or arising from death, injury or damage to persons or property that occurred or are alleged to have occurred in whole or in part in connection with the conduct of Underground Boring or are in any way related to this Permit.
- 8. Permittee acknowledges that they are competent, of lawful age, and has legal authority to enter into this Permit and executes this Permit as a free and voluntary act.
