I am writing this email to recommend the retirement of Ambulance 7R and the current Deputy Chiefs truck Battalion 7. The amount of time and money necessary to make and keep these 2 vehicles reliable and safe far surpass their worth.

Ambulance 7R is a 1999 Ford E450 with 60,924 miles on it. The engine has 856 hours on it. The engine has been rebuilt once before my employment. The turbo has been rebuilt at least once as well. The engine and turbo are not running correctly. The suspension needs to be rebuilt. There are many electrical issues currently as well. The air conditioning needs to be replaced in order to meet IDPH standards for patient care.

Battalion 7 is a 2005 Chevy Silverado 2500HD with 142,661 miles on it. The rocker panels are completely rusted through to the extent that you can see the ground through the floor while sitting in it. There are issues with the transmission and engine as well.

If you have any questions or concerns please let me know.

I am requesting that we seek approval to sell these two vehicles at the May 2nd, 2022 Board meeting. They will be stripped of valuable radios, lights, and equipment prior to their sale.
